The proposed 2026 budget is increasing \$152,200 (13.4%) from the 2025 budget. Unrestricted Fund Banlance of \$130,675 is being utilized to maintain the current tax rate of \$0.055 per \$100 of assessed value. The tax levy is increasing \$21,525 (2.0%) from \$1,074,455 to \$1,095,980. Capital appropriations are increasing \$162,165 (68.2%) to \$400,000 set aside for future capital purchases. Debt payment is decreasing \$3,000 (3.5%) and interest payment are decreasing \$6,965 (22.8%) based on the loan amortization schedule.

The proposed 2026 budget is increasing \$152,200 (13.4%) from the 2025 budget. Tax revenue is increasing \$21,525 (2.0%) from \$1,074,455 to \$1,095,980 in the 2026 budget. Unrestricted Fund Balance utilized is increasing \$130,675 (100.0%) to maintain the current tax rate of \$0.055 per \$100 of assessed value. There will be sufficient fund balance remaining to begin operations in 2027. No Cap Bank was used in the 2026 budget. The budget is in compliance with the Property Tax Ley Cap.

The proposed 2026 Budget has \$400,000 of appropriations for future capital outlays. In 2023 the District began paying a portion of the cost of a Howell Township project to upgrade the radio communications systems in the township. The anticipated principal and interest payment for 2026 is \$105,635. Future principal and interest payments will vary in future years based on the amortization schedule. The bond is anticipated to be paid off in 2032.
