## Workshop Meeting, December 7, 2015

## CRITICAL CORRESPONDENCE:

We received a quote from Brian Wallace at VFIS to increase the umbrella policy from \$2MM/\$4MM to \$5MM/\$10MM at a cost of \$1,800 annually. Brian also responded to my e-mail pertaining to the insurance coverage regarding 1<sup>st</sup> responder calls.

**OLD BUSINESS**: Discussed outstanding medical bills with Lab Corp. and Bricktown Medical. Commissioner Acampora stated he spoke with a representative at Lab Corp. and they will be removing the bill for the individual that is not associated with the Ramtown Fire Company. Bricktown Medical is also still reporting past balances dating back to 2012 and prior. He stated he will contact Bricktown Medical again to have this corrected.

Chairman Scarlato reviewed the list of members that have still not received their physical for 2015. This list will be turned over to the Chief for him to address with the individual fire fighters. It has been noted that if the members do not complete their physicals by year end 2015, that the commissioners will need to take action, which could be possible suspension of the fire fighter.

Chairman Scarlato noted that he received the contract for hiring of a Medical Director/Administrator. The cost is \$2,000 annually. He has forwarded the contract to Senzik & Sendzik for review.
