Workshop Meeting, July 13, 2015

OLD BUSINESS: None noted.

NEW BUSINESS:

We received the following bids to reconfigure the compartment on Ladder 490:

NJEV - \$1,300 1st Priority - \$1,085

A motion was made by Commissioner Stalling and 2nd by Commissioner Bommer, that we accept the price from 1st Priority of \$1,085 to reconfigure the compartment. Motion passed unanimously by the board.

EXECUTIVE SESSION: There was no Executive Session.

NEW TRUCK: We have received a letter from KME requesting that the company be granted permission by Ramtown Fire Company to drive Engine 480 to Wildwood in September for display at the NJ State Fireman's Convention. KME will be 100% responsible from the time they pick-up the apparatus until the time it is returned. They will provide the Board proof of satisfactory insurance. The board was in agreement to allow KME permission to take the apparatus to Wildwood.

A motion was made by Commissioner Bommer and seconded by Commissioner to spend the additional \$413.00 when the truck goes back to KME for service. Motion passed unanimously by the board.

PAYROLL: None

TREASURER'S REPORT: Following the completion of the voucher and check entry by Treasurer Stalling, he reported 20 bills totaling \$32,614.80. In order to cover the expenses, \$33,000.00 will be transferred to the general account.

Chairman Scarlato noted that the check that was approved for payment to Defender has not been sent for payment, as we have not received all of the equipment that was listed on the invoice. The check for Skylands Equipment in the amount of \$6,700 was mailed, as we finally received the fans that were ordered.

Chairman Scarlato noted that we have received the thermal imaging camera for Engine 480 from Safe T. The invoice was received in the amount of \$9,145. The salesman (John Bradle) informed Chairman Scarlato that the camera price is \$8,995 and includes a flashlight to be mounted on top of the camera and he will provide specialized training at our request. Paying is being withheld until all issues have been addressed and corrected. It was requested that Clerk Acampora send a letter to Safe T addressing our concerns.

The Treasurer's Report was accepted on a motion by Commissioners Eadicicco and seconded by Commissioner Bommer. The motion was passed unanimously by the board.

GOOD AND WELFARE: Nothing was reported.

PUBLIC COMMENT: There were zero (0) members of the public present and there were no comments offered.

ADJOURNMENT: This concluded the business for the workshop, so a motion to adjourn was made by Commissioners Stalling and Bommer, and passed by the board.
