## **NEW BUSINESS:**

The Board received a proposal from Fail Safe Hose Testing to enter into a 3 year contract that will cap our hose testing cost at \$2,255.00. This will be per year, for the next 3 years. The board fees that it will be in our best interest to enter into this 3 year agreement. We will vote to approve this at tomorrow's business meeting.

Chairman Scarlato stated the fire company is discussing possibly changing the company patch and placing the patch on the outside are of the Class A uniform jacket. It was discussed the Board of Fire Commissioners purchases the Class A uniform for all fire fighters once they have completed their probationary period and passed Fire Fighter I class. As such, the Board will discuss possibly contributing to the purchase and application of the patch to the jacket.

Allied Health Systems will be performing the fire fighter physicals on Saturday, May 14, 2016. It was noted that all fire company members requiring a physical will receive a letter from the board discussing the process, date, and time the physicals will be performed. They will also be provided with the initial patient history application that must be completed by each fire fighter prior to having their physical completed.

The Board discussed the possibility of returning the foam trailer to the Western Monmouth Mutual Aid Association. We are currently running out of room at the fire house and we have housed the trailer for the past 10 years. Commissioner Bailey stated that he will bring it up at the next WMMAA meeting.
