Chief is looking to purchase the APX 8000 at a cost of \$10,612 per radio, less 25% discount, making the total \$7,959 per radio.

The APX 6000 would cost \$4,839, less 25% discount, for a total cost of \$3,600. This radio will not allow us the capability to expand to additional frequencies and also incorporate Ocean county radio frequencies.

The radio for the new command vehicle (APX 7500) will cost \$7,500 for 2 radios.

NEW BUSINESS:

The new command vehicle should be in DE by the end of June 2016. It will be delivered to the fire commissioners by the dealership.

A brief discussion ensued regarding what to do with the old vehicle command vehicle.

The new lighting was installed on Brush 494, but it needs go back to East Coast so the lights turn on and off with the master battery switch.

Commissioner Bommer cleaned out the closet will dispose of the old computer and printer. The hard drive in the computer will be destroyed prior to disposition.

Commissioner Bommer is still working to contacting the plumbing so the items can be addressed. He will also obtain a price from the electrician for correcting the electrical issues with the boiler.

It was noted that all personnel files should be kept with the Chief and not with the Board of Fire Commissioners.

We received a letter from the Chief Engineer (Martin Kelly) that John Thompson is resigning as an engineer. As such, the Chief Engineer would like to appoint Ricky Romanon to fill his position. Mr. Romano was already presented by the Chief in January 2016 to fill Mr. Kelly's position as Engineer when he retires in June 2016. All stipends for both Mr. Thompson and Mr. Kelly with be paid in December 2016 will all other company stipends.

It was noted that the new command vehicle may be delivered prior to the next Board meeting. The Board will approve at tomorrow night's meeting to pay the dealership upon delivery and inspection of the vehicle.

Past Commissioner Eadicicco was never presented with the plaque from the board for his years of service on the board. Chairman Scarlato stated he will look into purchasing a plaque to be given to him at a later date.
