Chief's Report

The call reports and vehicle 467 & 466 reports were provided.

The Chief reported all portable radios have been reprogramed and are working well. The radios in the vehicles and the old Motorola 1250s will be reprogramed at a later date.

New Jersey Natural Gas has requested to send an additional two (2) fire fighters to MA for training and will pay for the training. The commissioners agreed that additional expenses (meals, lodging, travel) will be paid for out of the training budget for two (2) fire fighters to attend the training.

Repurposing of vehicle 486 will be completed by 12/15/18. Additional ice rescue equipment is now on this vehicle. All extrication equipment will be removed from this vehicle and placed on Ladder 490.

Scheduled delivery of the new SCBA packs from MSA is not known at this time.

The Chief is requesting that the fire police badge be given to fire fighter McMahon. Chairman Scarlato stated that ex-chief Connolly had sworn in fire fighter McMahon to fire police without first receiving approval from the Board of Fire Commissioners. In order to ensure fire fighter safety, all responding member responding to a call shall wear full NFPA protective gear. Fire fighter McMahon will need to respond wearing the newly purchased gear. As such, the Board has determined that there is no need to issue a fire police badge.

Chief Gotto stated that there was an issue with the repeater on West Farms Road being down which created radio issues. The issues have since been addressed.

Chief Gotto stated the 2019 officer swearing in ceremony will be on 1/1/19 at 11am at the Ramtown fire house. All are welcome to attend.

Chief Engineer

Chief Engineer Gilsenan was not attendance, but did submit a report to Chairman Scarlato.

All maintenance services have been completed on Ladder 490, with the exception of the replacement of the radiator hose.

A list of additional upgrades to be performed to Ladder 490 were provided to Fire & Safety and Defender, with the following quotes being submitted:

Fire and Safety - \$19,678.00

Defender - \$17,439

The two (2) proposals were reviewed by the Board and determined to be comparable to the initial quote request.

A motion was made by Commissioner Bommer and seconded by Commissioner Bailey to proceed with the upgrades to Ladder 490, to be performed by Defender at a cost not to exceed \$17,439.00. The motion passed unanimously by the Board.

Purchaser:

All hose nozzles were received.

Chief Gotto is reviewing the purchase order and what was shipped, as he believes the nozzles that we received are not the correct one.

The computer backup is schedule to begin in January 2019.

Printer approved at previous meeting for \$250 has not been ordered yet.

The Chief would like to purchase a new gas meter for vehicle 466 instead of purchasing the 3 pairs of bolt cutters that were approved at a previous meeting. The expense will remain the same. The Board approved this substitution.

New white helmet has been ordered for Assistant Chief Murphy.
