### **Executive Board**

There was no meeting held in December 2018. Next meeting on 1/24/19.

### Chief's Report

Chief Gotto handed in all vehicle and call reports.

Chief Gotto has requested to send two (2) fire fighters to the Middletown Fire Academy to receive their Fire Fighter I training and certification. These two (2) fire fighters missed the cut-off to register for the class with the Monmouth County Fire Academy and the chief states that this is the only academy class that is available until September 2019. The cost will be \$350 per fire fighter.

A motion was made by Commissioner Bommer and seconded by Commissioner Bailey to send fire fighters Phleger and Cho to the Middletown Fire Academy at a cost not to exceed \$700. The motion was unanimously approved by the Board. Chairman Scarlato noted that this is a onetime exception and that all fire fighters are still to attend Fire Fighter I classes at the Monmouth County Fire Academy.

Chief Gotto spoke about the formation of the Communications Committee, which will include one (1) commissioner and one (1) line officer from each fire company to discuss any radio communication issues. The Chief stated he will be the line officer attending these meeting and the Board stated Commissioner Bommer would be attending on the Board's behalf.

The Fire Bureau has contacted the Chief and the Board and requested a copy of our Social Media policy. They were informed that we do not currently have one. The Chief has informed all members via E-Dispatch that under no circumstance are any photos to be taken at any 19-4 incident and posted on Social Media. The Board and the Line Officers will work on creating a Social Media policy to be implemented by the Board.

The new printer has been received for the radio room. The printer and the computer backup system will be installed beginning 1/9/19.

Chief Gotto stated that the last set of Class A uniforms received from Bob's Uniforms were incorrect. Both had the American Flag on the arm of the jacket. Clerk Acampora stated he will review the letter that is sent to Bob to make sure it does not state this and he will follow-up with a phone call to Bob's Uniforms.

There is an issue with the Red Alert System that All 5 township companies are experiencing. Red Alert has been notified and they are addressing the problem.

Chairman Scarlato stated that Ladder 490 would be going out for service in the next few weeks to have the additional work completed. It will be out of service for 3-4 weeks. Chief Gotto stated that the emergency lights on vehicle 466 have been replaced and were covered under warranty.

It was noted that the gas meters are going to need their quarterly service.

### Purchaser:

Commissioner Bailey stated that the gas meter has been ordered, along with the two (2) batteries for the stand-up Stream lights.

The Chief is still investigating the new nozzles that we received in December 2018 to make sure they are the correct ones that he wanted.

Chairman Scarlato noted that fire fighter Danny Gaul was not reported on the year-end percentage report and is due his stipend based on his percentage. Chief Gotto stated that he would provide this information to the Board so that his stipend can be issued.
