The received information from Howell Twp. OEM pertaining to man hours worked during the hurricane in August 2020. All information was sent to Howell Twp. OEM for submission and reimbursement by FEMA. There are several fire fighters requesting to take the Fire Fighter II Class. The cost of the books is \$125. Any fire fighter wishing to attend the class will have to purchase the books on their own and submit the invoice for reimbursement by the Board.

There are currently 5-6 members interested in attending an Advanced SCBA class through All Hands Fire Training. The cost would be \$250 per student. The line officers will get back to us with an exact amount and also look into having a class just for our department.

TRUCK COMMITTEE:
