

RESOLUTION RESETTING DATE, TIME AND PLACE OF THE ANNUAL FIRE
DISTRICT ELECTION PURSUANT TO N.J.S.A. 40A:14-72(B)

WHEREAS, N.J.S.A. 40A:14-72(b) requires the Board of Fire Commissioners to set a date annually for the holding of the annual Fire District Election and to establish the time and place thereof; and

WHEREAS, in the past, the Board has held its annual election on the third Saturday in February as set forth in the statute between the hours of 2:00 p.m. and 9:00 p.m., or longer if necessary, at Ramtown-Howell Fire Company No. 2, 88 Ramtown-Greenville Road, Howell, New Jersey; and

WHEREAS, the Board found that the prior arrangements for the annual election have been in the best interest of the District and resolved, on December 8, 2020, to set the date of the annual election as February 20, 2021, between the hours of 2:00 p.m. and 9:00 p.m., or longer if necessary, to be held at Ramtown-Howell Fire Company No. 2, 88 Ramtown-Greenville Road, Howell, New Jersey; and

WHEREAS, pursuant to Governor Philip D. Murphy's Executive Order No. 211 dated and effective December 21, 2020, any fire district election scheduled between January 12, 2021, and April 19, 2021, shall be postponed until April 20, 2021; and

WHEREAS, the Board finds it necessary to reset the date, time and place of the annual fire district election.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners of Fire District No. 4, Township of Howell, County of Monmouth, State of New Jersey, that it reset the date of the annual election to April 20, 2021, between the hours of 2:00 p.m. and 9:00 p.m., or longer if necessary, to be held at Ramtown-Howell Fire Company No. 2, 88 Ramtown-Greenville Road, Howell, New Jersey; and

BE IT FURTHER RESOLVED, that the Fire District administration take all necessary action to make arrangements for the appropriate voters' list, challengers, mail-in ballots, security and other necessary action to effectuate the within Resolution; and

BE IT FURTHER RESOLVED, that the within Resolution shall be effective immediately upon passage; and

BE IT FURTHER RESOLVED, that any resolution or part of a resolution inconsistent herewith is hereby repealed or otherwise revoked; and

BE IT FURTHER RESOLVED, that if any section, paragraph, sentence, clause or phrase in this Resolution is for any reason held or determined to be unconstitutional or invalid, same shall not affect the remainder of this Resolution; and

BE IT FURTHER RESOLVED, that notwithstanding anything set forth herein to the contrary, the Board shall be permitted to amend, modify, repeal or otherwise act as to those topics which are the subject of this Resolution provided said acts are consistent with public policy, Board bylaws, township ordinances, local, state and federal laws and rules and regulations promulgated thereunder; and

BE IT FURTHER RESOLVED, that an original signed, conformed and compared copy of this Resolution be accessible and maintained as an official Board record pursuant to and in accordance with the "Open Public Records Act"; N.J.S.A. 47:1A-1, *et seq.* and the "Destruction of Public Records Law (1953)"; N.J.S.A. 47:3-8.1, *et seq.* as set forth by the State of New Jersey Municipal Agency Record Retention Schedule promulgated by the Division of Archives and Record Management.
