#### **REORGANIZATION MEETING MARCH 12, 2024**

Chairman Greg Scarlato called the meeting to order at 19:30 hours followed by the Pledge of Allegiance.

Chairman Scarlato read the following legal disclosure:

Roll call was taken with Commissioners Scarlato, Stalling, Bailey, Romano, and Acampora all in attendance.

It was noted that there were zero (-0-) members of the public in attendance.

Chairman Scarlato noted that the sole purpose of the tonight's meeting is to reorganize the business positions for the year 2024.

Chairman Scarlato issued the Oath of Office to re-elected commissioners Ricky Romano and Michael Acampora. After administering the oath of office, Commissioners Romano and Acampora were congratulated by everyone in attendance.

Commissioner Stalling made a motion, which was seconded by Commissioner Bailey, to accept the commissioners and their new positions as stated above. The motion was unanimously approved by the Board.
